WEST ALLIS, Wis. - A vacant West Allis Burger King at the center of a months-long legal battle came down Tuesday, Feb. 6. Court filings dated Oct. 9, 2023 show the city sued the restaurant chain, asking the court to declare the property near 106th and Greenfield a "public nuisance." The lawsuit also stated the city issued written notice of its complaints to Burger King in May - and alleged the company failed to adequately address defects. SIGN UP TODAY: Get daily headlines, breaking news emails from FOX6 News In September 2023, the lawsuit said, Burger King had taken action but failed to meet the city's desired level of repair. A broken window was fixed, but the glass from the originally broken window was left on the sidewalk. Some "minor paint" was added, but the paint was directly over rotted wood. Concerns about the parking lot asphalt were not addressed, the lawsuit claims. After legal negotiations, Mayor Dan Devine announced in December that Burger King decided to just raze the building - and return the area to a grass lot. It is not clear what will be built on the lot. "We're always trying to fix the problems that we learn about in our community. We don't get everything done that we hope. But this is a victory," Devine told FOX6 News last year. West AllisNews It looks like the beef between the City of West Allis and Burger King has finally come to an end. Mayor Dan Devine announced on Friday, Dec. 8, that Burger King has decided to raze the abandoned Burger King building that has been sitting vacant for over a decade. The demolition is set to begin around Dec. 27, according to the mayor's tweets. Back on Oct. 5, Devine called the burger chain out on X saying: "Since 'I rule' could you please help me and do something with this 'Whopper' of a blighted property (on 106th and Greenfield) that has been an eyesore for West Allis for several years? Thanks in advance!"The official Burger King account on X responded within minutes asking Devine to send them a private message. He did, but the company did not reply, until recently, according to the mayor. "It's very frustrating that it's such a blight and on such a main intersection," Devine said at the time. To add heat to the fire, a few days later on Oct. 13. The suit focused on two issues - the existing issue that has been a problem for West Allis for at least six years and possibly up to 11 new violations found since the notice of nuisance was issued, according to City Attorney Kail Decker. "It appears that the entire electrical service was removed from the building," Decker said. The property is currently overgrown with weeds, but is it still legally owned by Burger King Company, LLC. Burger King is a subsidiary of Restaurants Brands International, but Decker stated the city is suing the listed property owner as opposed to RBI.Decker previously sent Burger King a broken window, but left broken glass on the ground, and painting over rotting wood.

Decker said the paint bubbled off in under a few months. "All we want is the property activated," Decker said, adding the city is fine if Burger King to avoid is just more of the same. The City of West Allis said the building, or sell it to a new buyer. According to the lawsuit, the City issued a written Notice of Public Nuisance in May to Burger King Company. The notice said the property had broken windows, peeling paint, and a deteriorated parking lot. On September 14, the complaint alleged the West Allis Code Enforcement Director inspected the property. So a few days later on Oct. 9, the city filed a lawsuit against Burger King in May 2023, saying the property was overgrown with weeds, contained broken glass and had painted wood that was rotting underneath.
