You have said that your son in law will accommodate you whilst you are in the United Kingdom and I am satisfied that he is in a position to do so based on the documents provided and the interview that we conducted. While I take that into account in assessing your proposed maintenance and accommodation in the UK, this is only one aspect of the visitor rules and this sponsorship does not satisfy me of your own intention to leave the UK on completion of your visit.
- I am aware of the importance of this visit to you; however I am not satisfied that these culturalships. outweigh my other concerns against the requirements of the Immigration Rules. I have considered the evidence provided and written statements you have made, but I am not satisfied you have met the requirements of the Immigration Rules on this occasion.
